Oratory Contest

Oratory contest: specific subjects, no theme

Open to any Oregon high school student who is a junior or senior as of February 1st, 2021. Contestants are to research, write, and present an original pro-life speech on abortion, infanticide, euthanasia or stem cell research. The **speech must** address one of these topics directly. First place winner of each local contest competes at State during the Oregon Right to Life TWA Conference in Tualatin Oregon on March 6, 2021. First place winner of that competition presents their speech at the Conference that day.

State Contest 1st Place - \$600

Plus-expense paid trip to compete in the National Right to Life Oratory Contest with the opportunity to win \$1,000 in that competition

State 2nd Place - \$400 prize

State 3rd Place - \$300 prize

Video Contest

Youth: ages 10-13 1st Place \$300

Junior: ages 14-17 1st Place \$500

Adult: ages 18 + 1st Place \$500

Video State Deadline: February 8, 2021
